1. **IMPORTANT NOTES**

- GIRO Application is only applicable for regular premium insurance policies denominated in Singapore dollars.
- The approval process for GIRO application using this application form is approximately 2 months. Until your GIRO application is approved, kindly remit premium payments directly to China Taiping Insurance (Singapore) Pte. Ltd ("CTPIS").
- 3) Once GIRO application is approved, you will need to ensure that sufficient funds are maintained in your bank account for the next scheduled deduction.
- Scheduled deduction dates are fixed with the banks and cannot be changed. However, if a scheduled deduction date falls on a Public Holiday or weekend, deduction will take place on the next working day.

- I/We hereby instruct you to process instructions from CTPIS to debit my/our account to pay for my own and/or my Family member's policy(ies). "Family Members" shall refer to spouse, children, parents and siblings (for single applicants only).
